*"Ramsgate Town Council is extremely concerned regarding proposals for the development of Manston airport into a major freight hub. It considers that this development would have a severely detrimental impact on the future development of Ramsgate if it led to night time flying or the imposition of*

*Public Safety Zones restricting development across Ramsgate. We call upon the administration at Thanet District Council to honour pledges made to defend the environment against harmful development, in particular to oppose night time flying."*

**Seconded by Cllr Campbell.**

The Clerk cautioned the meeting and pointed out that the resolution conflicted with standing order 9.1. The meeting noted the caution and continued. After a subsequent debate the matter was put to the vote.
