**166. QUESTIONS FROM THE PUBLIC**

**169. ALBION GARDENS PULHAMITE GRANT**

The Clerk reported that a grant had been received to survey the Pulhamite rock work in Albion Gardens. The Clerk explained because of the very tight deadlines required by the Coastal Revival Fund and paucity of expert contractors to carry out the work required, the Council was being asked to suspend normal procurement process and to suspend standing orders for this single project. The Clerk also said that the survey work would be extended to other parts of the Pulhamite estate in Ramsgate, as Historic England was applying for funding for the additional items such as analysis of the Pulhamite and training to enable repairs to be done by RTC and others. A habitat survey would be done by the Kent Wildlife trust as part of the project and is allowed for in the Grant funding.

Cllr Campbell proposed that standing orders 35.3 to 35.8 be suspended for this single project because of the specialist nature of the contract and the requirement to secure a contract before 31<sup>st</sup> March 2019. The Morton partnership and Kent Wildlife Trust are therefore appointed as contractors to carry out the specific functions in the implementation of the work specified by the document donating the grant.
